

Readmission Frequently Asked Questions

Welcome to the Readmission FAQ page! Here, we provide answers to common questions about the readmission process. For additional questions or personalized assistance, contact a retention advisor at readmissions@tcc.edu.

What is Readmission?

Readmission allows students who were academically suspended or dismissed to return and continue their studies.

How do I know if I am eligible for readmission?

You may qualify for readmission if:

- You are a TCC student and were academically suspended or dismissed and have met the reapplication criteria, such as sitting out for a semester following suspension or dismissal.
- You are a student from another college and were academically suspended or dismissed from the college.

How do I apply for readmission?

To apply, complete the Readmission Application.

What documents are needed for the readmission process?

Depending on your circumstances, you may need to provide:

- A completed Readmission Application
- Academic transcripts from any other institutions you attended (Students do not need to send TCC transcripts.)
- The Student Responsibility Agreement (This document will be provided in the meeting with the retention advisor.)

What happens after I submit my application?

After submitting your application:

• A retention advisor will reach out to review your documents.



- The dean of retention will assess your application to determine approval or denial for the upcoming semester.
- You will meet with a retention advisor to discuss your academic history, current standing, and future academic plan.
- If you are returning after academic suspension or dismissal, you may also need to meet the reinstatement conditions for <u>Satisfactory Academic Progress (SAP)</u>.

Can I be readmitted after academic suspension or dismissal?

Yes, you can reapply after academic suspension or dismissal. You must:

- Meet the conditions for readmission, such as sitting out the semester following suspension or dismissal.
- Submit the <u>Readmission Application</u>. You can email any additional questions or supporting documents to <u>readmission@tcc.edu</u>.

What is the deadline for readmission applications?

Submit your <u>Readmission Application</u> at least **2–3 months** before the semester begins to allow sufficient time for review and advisement.

Can I apply for financial aid after being readmitted?

Yes, we recommend contacting our financial aid office to check your eligibility. Complete the <u>Free Application for Federal Student Aid (FAFSA)</u> as soon as possible. Your eligibility may also depend on meeting <u>Satisfactory Academic Progress (SAP)</u> requirements.

How will I know if my readmission application is approved?

You will receive an email notification after your application has been reviewed and a decision made (usually within 5-7 business days). Check your college email regularly for updates.
